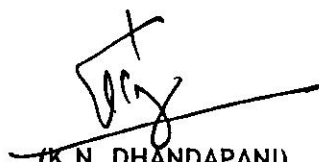
ORDER

Consequent to the order in Notification No. 5 dated 15.11.2014 of the Principal Chief Commissioner of Income-tax, Tamilnadu in C. No. CHE/COORD/112(2)/JURSDN/2014-15, the designation of the Commissioner of Income-tax (Appeals) having jurisdiction over persons, assessed in International Taxations, LTU, TDS and Exemptions were modified. The Appeals pending before the erstwhile CIT(Appeals) – I and CIT(Appeals)-VII Chennai is now bifurcated between newly created CIT(Appeals)-16 and CIT(Appeals)-17.

- CIT (Appeals) -16 has jurisdiction over persons assessed in International Taxation.
- CIT (Appeals) -17 has jurisdiction over persons assessed in Exemptions, LTU and TDS.

In order to ascertain the present jurisdiction of the pending appeals, in the case of any given assessee, the details of old ITA No. and the corresponding new ITA No. are given in a tabular form. Appellants are requested to quote the new ITA No. in all communication, and contact the new Jurisdictional Appellate Commissioner.
